

Privacy Policy - FreedomBecause.net

What this privacy policy covers

This policy covers how Jaywalker Records Ltd treats personal information that they collect on this and other web sites, including information related to your past use of the site such as previous order details.

Personal information is personally identifiable information about you such as your name, address, email address, phone number and so on, that is not normally publically available.

This policy does not apply to companies that Jaywalker Records LTD does not control, or to any third parties that Jaywalker Records LTD does not employ or manage. Information collection and use

Jaywalker Records LTD collects personal information when you register with Jaywalker Records LTD and when you use Jaywalker Records LTD 's site.

When you register we ask for information such as your name, email address, birth date, gender, zip code. Once you register with Jaywalker Records LTD and sign in to our services, you are not anonymous to us.

Jaywalker Records LTD collects information about your transactions with us.

Jaywalker Records LTD automatically receives and records information on our server logs from your browser, including your ip address, Jaywalker Records LTD cookie information, and the page you request.

Jaywalker Records LTD uses information for the following general purposes: to fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for our management team and or our web team.

Information sharing and disclosure

Jaywalker Records LTD does not rent, sell, or share personal information about you with other people or companies except to provide products or services you've requested from our site(s), when we have your permission, or under the following circumstances:

We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims. We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Jaywalker Records LTD 's terms of use, or as otherwise required by law.

If Jaywalker Records LTD is acquired by or merged with another company, Jaywalker Records LTD will notify you before information about you is transferred and becomes subject to a different privacy policy.

Cookies

Jaywalker Records LTD may set and access Jaywalker Records LTD cookies on your computer and uses cookies in connection with Jaywalker Records LTD 's site for your benefit.

Your ability to edit and delete your account information and preferences.

You can edit your Jaywalker Records LTD account information, including your address and contact details at any time. You cannot directly change the name, address, contact details and other details of existing orders, but can contact Jaywalker Records LTD to change order details if you need to.

We reserve the right to send you certain communications relating to the Jaywalker Records LTD store such as relevant service announcements and administrative messages, that are considered

part of your Jaywalker Records LTD account, without offering you the opportunity to opt-out of receiving them. You can remove your Jaywalker Records LTD account which will stop you being sent these messages. Please note that if you place an order with the site, that Jaywalker Records LTD will keep a permanent record of your details as entered at the time of the order.

Confidentiality and security

We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.

We have physical, electronic, and procedural safeguards to protect personal information about you. We also comply fully with the uk data protection act.

Changes to this privacy policy
